ORDER

In accordance with the Right to Information Act,2005 (No.22 of Central Act 2005) Government have constituted Kerala State Information Commission consisting of a State Chief Information Commissioner (Equivalent to the rank of Central Election Commissioner) and four State Information Commissioners (Equivalent to the rank of Chief Secretary) as per the orders read above. As laid down in section 16(5)(b) of the Act, Government are now pleased to order that the salaries and allowances payable to and other terms and conditions of service of State Information Commissioner will be as follows:

Pay and Allowances

Basic Pay	: Rs.26,000/- p.m.
Dearness Pay	: Rs.13,000/- p.m.
Dearness Allowance, CCA & HRA	} : At the rate applicable to Government of India Officers.

In the case of retired Government Officer, the amount of pension sanctioned to him/her will be deducted from the total amount due to him/her as State Information Commissioner.

Leave

1. The State Information Commissioner will be entitled to have leave as applicable to the members of the Indian Administrative Service.
2. The power to grant or refuse leave to the State Information Commissioner shall be vested with the State Chief Information Commissioner.
3. For encashment of Earned Leave, the All India Service Leave Rules, 1955 will be applicable.

Travelling Allowance/LTC facility

1. The State Information Commissioner will be entitled to get Travelling Allowance as per the Travelling Allowance Rules of Government of Kerala.
2. The State Information Commissioner will be entitled to get Leave Travel Concession for himself/herself, his/her spouse and the dependant members as per Government of India Rules, prescribed for the purpose.

Medical Facility

The State Information Commissioner will be given medical reimbursement facility as applicable to the Chief Secretary to Government of Kerala.
