Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per sub-section (3) of section 15 of the Right to Information Act, 2005, the State Chief Information Commissioner and the State Information Commissioners shall be appointed by the Governor on the recommendation of a committee constituted under that sub-section. As per notification No. 80649/Cdn.5/05/GAD, dated 19th December, 2005 published as S.R.O. No. 1091/2005 in the Kerala Gazette Extraordinary No. 2731 dated 19th December, 2005. The Kerala State Information Commission was constituted with a State Chief Information Commissioner and four State Information Commissioners.

As per G. O. (Ms.) No. 85/2012/GAD, dated 25th April, 2012, one more post of State Information Commissioner was created in the Kerala State Information Commission. As per notification No. 48398/CDN5/2015/GAD, dated 10th May, 2018 four State Information Commissioners have been appointed and one post of State Information Commissioner remain vacant. The committee constituted under sub-section (3) of section 15 of the Right to Information Act, 2005, made recommendation to the Governor to appoint Shri Rajeevan, H. as the State Information Commissioner in the existing vacancy. The Governor of Kerala ordered to appoint Shri Rajeevan, H. as State Information Commissioner of the Kerala State Information Commission.

The notification is intended to achieve the above object.
