**ANNUAL REPORT FOR THE YEAR 2017-18**

“.....Democracy requires an informed citizenry and transparency of information which are vital to its functioning and also to contain corruption and to hold Governments and their instrumentalities accountable to the governed.”

(Preamble to RTI Act, 2005)

**I. Introduction**

The main objective of the Right to Information Act, 2005 is to ensure transparency and accountability in the working of every Public Authority in the country and to eliminate the scourge of corruption. The Act mandates a legal-institutional framework for setting out a practical regime of right to information for every citizen to secure access to information held by or under the control of Public Authorities. This is a path-breaking legislation that enables the country to break away from the colonial legacy of secrecy, which is anathema to a democratic system. Setting up of Information Commissions at the Central and State levels to ensure the effective implementation of the right to information regime in the country is one of the key provisions of the Act.

**II. Constitution and Composition of the Kerala State Information Commission**

The Kerala State Information Commission was constituted under section 15(1) of the Right to Information Act, 2005, Vide G. O. (P) No. 367/2005/GAD dated 10-10-2005. Vide G. O. (Rt.) No. 9294/2005/GAD dated 9-12-2015 Government ordered that the State Information Commission shall consist of a State Chief Information Commissioner and four State Information Commissioners Vide G. O. (Ms.) No. 85/2012/GAD dated 25-4-2012 Government created one more post of State Information Commissioner in the State Information Commission. During the Report period 2017-18, only the State Chief Information Commissioner was in office. The State Chief Information Commissioner for the report period is Sri Vinson M. Paul IPS (Rtd.).

**III. Functioning of the Commission**

The office of the State Information Commission is situated in Building No. T.C. XXVI/298, Punnen Road, Thiruvananthapuram-695 001. Official telephone numbers of the State Chief Information Commissioner and State Information Commissioners and other officers of the Commission are at Annexure-I.

An amount of ₹ 4,70,66,000 lakh was provided in the State Budget (Non-Plan) to meet the expenses of the State Information Commission during the year 2017-18 and the expenditure incurred was ₹ 2,36,62,734 lakh.

#### IV. Administration of the Act

##### 1. PRO-ACTIVE DISCLOSURE OF INFORMATION

Section 4 of the Right to Information Act, 2005 provides for mandatory/pro-active disclosure of information by the public authorities. The information required to be disclosed under this section include particulars of the organization including, functions and duties, rules, regulations, instructions, manuals and records followed for the discharge of functions, directory of officers and employees, including their monthly remuneration, its annual budget, details of subsidy programmes and concessions, and its beneficiaries, particulars of State Public Information Officer/s etc. The time limit for publishing the information under section 4(1) (b) was one hundred and twenty days from 15 June, 2005—the date of enactment of the Act. Earnest effort has been made by the Commissioners to educate and encourage the public authorities to take effective action as contemplated under section 4 of the Right to Information Act.

##### 2. DISCLOSURE OF INFORMATION AGAINST REQUESTS

A citizen, who desires to obtain information under the Act, is required to make an application before the Public Information Officer as provided in Section 6 of the Act. Where the request is for information, which is held by another public authority or the subject matter of the application is more closely connected with the functioning of another public authority, the application shall be transferred to the other public authority within 5 days of the date of receipt of the application, under intimation to the applicant. In many cases, the applications were not seen transferred to the public authority concerned within 5 days or intimation given to the applicant as provided in Section 6(3) of the Act. Section 7 of the Act provides for disclosure of information against requests made under section 6. When the request is rejected for any of the reasons u/s 8(1), 9 or 11, it is mandatory for the public authority to provide the reason/s for rejection, the period within which an appeal could be preferred and the particulars of the appellate authority etc. to the applicant. Here also, in a number of cases, where the requests were rejected, the above details were not communicated to the applicants. Another area where the provisions of the Act

were not strictly followed by the SPIOs was in making a demand for the cost of providing the information. The cost should be demanded in accordance with the provisions of Section 7(3) (a) giving the calculation made to arrive at the amount, and the particulars of the appellate authority. Very often, the SPIOs send notices to the applicants calling them to the office to remit the cost, without intimating the exact amount. The above are a few areas where the SPIOs require adequate training.

The right to information was often seen employed by the citizens as means to redress their grievances. The information seeker after the successful completion of the proceedings before the Commission is still insisting on issuance of specific orders by the Commission for the redressal of grievance, which had led to his/her, seeking information in the first instance. The Commission had been at pains to explain to the appellants/complainants during the hearings that this was not the role envisaged for the Commission under the Act and they have to seek redressal through appropriate forum based on other things and the information furnished to them by the orders of the Commission. Some applicants had difficulty in understanding the position and, were seen dissatisfied with the proceedings, even though the necessary information required by them had been furnished to them. However, it had been noticed in many cases that the act of the Commission to ensure supply of information, had indirectly aided redressal of the grievances through the public authorities. In many cases, the desired relief was extended to the citizens, even before the completion of the proceedings before the Commission.

##### 3. MONITORING AND REPORTING

Section 25(2) of the Act provides that each Ministry or Department shall in relation to the public authorities within their jurisdiction collect and provide to the Information Commission such information as is required, to prepare the Annual Report by the Commission. Accordingly, the Commission had written to the Secretaries of all the Administrative Departments of the Government Secretariat to collect the required details from the public authorities under them and forward the same to the Commission for the preparation of the Annual Report for the year 2017-18. All autonomous bodies and heads of departments were also similarly addressed by the Commission to furnish materials for inclusion in the Annual Report. Statistical analysis of the administration of the Act based on the data received by the Commission from the Government and the public authorities is given in Annexure-II (a) to II (e).

As per available information, the public authorities in the State had designated 33781 State Public Information Officers, 21779 Assistant State Public Information Officers and 5854 Appellate Authorities, for the implementation of the Act. The public authorities had received a total number of 394056 requests, out of which 387655 were disposed of. The fee and cost collected by the public authorities under various provisions of the Act was ₹ 9804031.

#### 4. NOTIFICATION OF INTELLIGENCE AND SECURITY ORGANISATIONS

Section 24(4) of the Act provides for notification, by the State Government, of intelligence and security organisations to which the provisions of the Act shall not apply. Accordingly, the Government of Kerala vide Notification issued as SRO No. 127/06 dated 7-2-2006 had notified a list of 8 intelligence and security organizations to which the provisions of the Act shall not apply. List of the eight State organizations so excluded is placed at Annexure-III. However, these organizations are not excluded from the purview of the Act as far as disclosure of information pertaining to allegations of corruption and human rights violations are concerned.

As per SRO No. 406/2013 dated 11-4-2013, Home (SS-A) & Home (SS-B) Departments in Government Secretariat are exempted from the purview of the Right to Information Act in matter dealing with secret/intelligence/confidential reports received from the 8 Intelligence and Security Organization notified under Section 24(4) of the RTI Act, 2005.

As per the notification issued under G.O. (P) No. 7/2016/GAD dated 27-1-2016 Government have included the State Vigilance and Anti-Corruption Bureau 'T' branch as an Intelligence & Security Organization under Section 24(4) of the RTI Act, 2005.

#### 5. COMPLAINTS AND APPEALS TO THE COMMISSION

The Information Commission has the original jurisdiction to receive and inquire into complaints under section 18 and second appellate jurisdiction under section 19(3) to receive appeals against the decisions of the First Appellate authorities. During the year under report, the Commission had received 14954 currents/references, out of which 1412 were registered as complaints, 3024 as second appeals. Besides, at the commencement of the year there was a pendency of 2511 complaints, 5839 appeals and as such total number of cases due for consideration by the Commission during the year under report was

3923 complaints and 8863 appeals. In the case of complaints u/s 18(1), complaints of other nature and appeals u/s 19(3), copies of the complaint/appeal are sent to the public authorities for their reports. Thereafter, the parties to the complaint/appeal are heard after issuing requisite notice to them and a decision is taken. The Commission hold hearings either in person or through video conference on almost all days of the week with a view to disposal of the complaints/appeals. During the period of report 716 complaints, 1769 appeals were finally disposed of, which is placed at Annexure-IV, along with graphical representation.

#### 6. LAPSES ON THE PART OF PUBLIC INFORMATION OFFICERS

Section 20 of the Act empowers the Central and State Information Commissions to impose penalty and for recommending disciplinary action against the PIO for the following lapses:

- (i) refusing to receive an application or not furnishing information within the prescribed time limit, without reasonable cause;
- (ii) malafidely denying the information;
- (iii) knowingly giving incorrect, incomplete or misleading information;
- (iv) communicating the applicant that the information, which was the subject of the request has been destroyed;
- (v) obstructing in any manner in furnishing information.

During the year of report, the Commission had initiated and completed action u/s 20(1) of the Act, 2005 and, had imposed penalty amounting to ₹ 274750 in 111 cases. Statement showing details of cases where in the Commission had imposed penalty from 1-4-2017 till 31-3-2018 is at Annexure-V. There is no case in which Departmental action has been recommended u/s 20(2) of the Act, 2005 and compensation awarded by the SIC u/s 19(8)(b) of the RTI Act, 2005 during the year 2017-18.

#### 7. COST AND FEE RULES UNDER THE RIGHT TO INFORMATION ACT

Sections 27 and 28 read with sections 6(1), 7(1) and 7(5) of the Act provide for prescribing fee for submission of application and the cost for providing the information. Accordingly, Government had notified the Kerala Right to Information (Regulation of Fee and Cost Rules), 2006 vide S.R.O. No. 385/2006 dated 9-5-2006. These rules provide for the mode of payment of application fee payable under the Act. These rules were amended vide S.R.O. No. 1074/2007

dated 18-12-2007 whereby the fee for providing information u/s 7(1) and 7(5) in the case of public authorities other than Government Departments has to be remitted by cash or by DD/Bankers Cheque/Pay Order payable to the SPIO/ASPIO concerned. The Government had also issued Erratum No. 29950/Cdn. 5/2008/GAD dated 28-5-2008 by which the application fee in respect of applications filed before public authorities other than the Government Departments shall be remitted in the form of Demand Draft/Bankers' Cheque/Pay Order payable to the State Public Information Officer/State Assistant Public Information Officer or by cash payment against proper receipt in the office of the State Public Information Officer/State Assistant Public Information Officer.

Proviso to Sub-section (5) of Section 7 of the Right to Information Act provides that, no fee shall be charged from the persons who are below the poverty line as may be determined by the appropriate Government. Accordingly, Government had issued G.O. (Ms.) No. 198/2007/LSGD dated 16-8-2007 by which the Block Development Officers in the respective areas have been authorized to issue certificates to BPL category citizens for seeking exemption from payment of fee and cost under the Act. The Government had also issued G.O. (Ms.) No. 41/2008/LSGD dated 14-2-2008 whereby the Secretary of the Municipality/Corporation has been authorized to issue certificates to BPL category citizens residing in the respective Municipality/Corporation area, for seeking exemption from payment of fee and cost under the Act.

Government had issued Kerala Right to Information (Regulation of Fee and Cost) Amendment Rules, 2015 vide G.O. (P) No. 20/2015/GAD dated 17-1-2015 whereby the free supply of materials under rule 4(1)(a) shall be restricted to 20 pages only. That is after the amendment BPL category is eligible for free supply of information to 20 pages only in A4 size paper and no material in larger size paper will be supplied free of cost.

Considering the difficulties faced by the public authorities in accounting the expenditure related to the cost of providing information as well as refunding the cost remitted by the applicants in certain cases, the Finance Department, Government of Kerala have issued Circular No. 61/2008/Fin. dated 15-10-2008, authorizing the public authorities on the action to be taken in such instances.

Government had issued the Kerala Right to Information (Regulation of Fee & Cost) Amendment Rules, 2014 vide G.O. (P) No. 268/2014/GAD

dated 25-9-2014 whereby it has been instructed to remit the application fee and fee for providing information in the Government Treasury, under the Head of Account 0070-60-118-99-Receipts under the RTI Act, 2005.

Government had further amended the Kerala RTI (Regulation of Fee and Cost Rules), 2006 vide G.O. (P) No. 338/2014/GAD dtd. 5-12-2014 incorporating additional provision for the mode of payment of application fee by cash remittance in the Akshaya Common Service Centres or at any agency duly authorized by the Government against proper receipt generated by the online software for this purpose or by electronic payment to the Government Account, if facility for receiving fees through electronic means like State designated e-payment gateway is available in the online software for this purpose.

#### 8. APPEAL PROCEDURE RULES

In exercise of the powers conferred under section 27 read with sub-section (10) of Section 19 of the Right to Information Act, 2005 the Government had notified the Kerala State Information Commission (Procedure for Appeal) Rules, 2006 vide S.R.O. No. 412/2006 dated 31-5-2006. Vide notification issued in G.O. (P) No. 247/2012/GAD dated 24-9-2012 and published as S.R.O. No. 676/2012, the Kerala State Information Commission (Procedure for Appeal) Rules, 2006 have been amended to the extent that self attested copies of the application made under section 6 and the document against which appeal was preferred to the Appellate Authority shall accompany the Appeal before the State Information Commission.

#### 9. GUIDELINES FOR HANDLING OF APPLICATIONS UNDER THE RTI ACT

The Government had issued 2 Circulars No. 77000/CDN.5/06/GAD dated 30-10-2006 containing detailed guidelines on the appointment of Assistant Public Information Officer (APIO), Public Information Officer (PIO) and Appellate Authorities in Public Authorities, and the procedure for disposing applications and 1<sup>st</sup> appeals received by the public authorities under the Act. These circulars were reported to be very useful by the public authorities for receiving and disposing of applications and 1<sup>st</sup> appeals under the Act. Subsequently, the Government had issued Circulars No. 54876/CDN.5/07/GAD dated 3-12-2007 and No. 58266/CDN.5/08/GAD dated 14-8-2008 on the same subject and the Government have issued certain guidelines for the smooth implementation of Right to Information Act, 2005.

#### 10. COMMISSION'S SITTINGS AT DISTRICT HEADQUARTERS

The State Information Commission is headquartered at Thiruvananthapuram and it does not have any other office in the State. As a people friendly measure, the Commission conducts sittings in other districts of the State, as far as possible. In addition to the above, Appeal Petitions and Complaint Petitions are disposed of through video conference too.

#### 11. TRAINING PROGRAMME

Section 26(1) of the Act provides that the Government may develop and organize educational programmes to improve the understanding of the public and also train Public Information Officers of Public Authorities and produce relevant training materials. The Institute of Management in Government (IMG) had been identified by the State Government as the nodal institution to train officers in the Government, PSUs and other autonomous organizations.

The Commission had taken active participation in the training and educational programmes. The Chief Information Commissioner and the Information Commissioners associate themselves with a number of educational and awareness programmes on Right to Information Act conducted by the IMG/other NGOs and various Government Departments. The Commission also participates in such training programs as resource persons and lend services of resource persons to various organisations to conduct classes on the Right to Information Act.

#### 12. INTERNSHIP

As a pro-active measure, the Commission encourages students to do internship in the Commission on various aspects concerning the Right to Information Act. A large numbers of students do internship in the Commission. The internees are allowed to take part in the Commission's sittings and study case files. They are also required to submit reports on their internship.

#### 13. SECTION 6(1) APPLICATION BEFORE STATE INFORMATION COMMISSION

During the period under report 497 applications under Section 6(1) of Right to Information Act were received by the State Information Commission and an amount of ₹ 5100 was collected towards the cost fee in respect of these applications. A total number of 36 Appeals under Section 19(1) of Right to Information Act were received.

#### 14. MALAYALAM TRANSLATION OF THE RIGHT TO INFORMATION ACT

In order that people are properly educated on the provisions of the Act, it was found necessary to have a Malayalam translation of the Act. The matter was taken up with the Government, and the Malayalam Translation of the Right to Information Act, 2005 was published in the Extraordinary Gazette of India on 8-2-2007.

#### 15. COMPUTERISATION OF THE COMMISSION

The Commission is fully computerized with LAN facility. The Commission's website [sic.ker@nic.in](mailto:sic.ker@nic.in) gives a wide range of information on its functions and activities.

#### 16. VIDEO CONFERENCING

The Appeal Petitions and Complaint Petitions received in SIC are disposed of through Video Conference also.

#### 17. RECOMMENDATIONS OF DOPT/STATE INFORMATION COMMISSION

##### (i) *Pro-active Disclosure by Public Authorities*

Even though pro-active disclosure was mandatory under section 4(1), it was noticed that pro-active disclosure was not done in a satisfactory manner by many public authorities. The public authorities should realize the importance of pro-active disclosure as, in the long run, such disclosure would reduce the number of requests for information. Hence it is recommended that Government suitably instructs the public authorities to disclose as much information as possible under section 4(1) of the Right to Information Act. Keeping in view of the cost and time elements involved in publishing and updating the information as per Section 4 of the Act, by print media, it is advisable to immediately publish the information by internet through the official website/s of the Government of Kerala and the organizations concerned. Organisations may be encouraged to develop their own websites and provide the information through them. Funds available under e-governance may be utilized for the purpose. Services of NIC can also be utilised. A definite time frame may be set for this.

It is suggested that strict directions are issued by the Government so that all the public authorities fulfill their obligations laid down under Section 4 of the Right to Information Act, 2005, and instance/s of failure to comply with the directions should be viewed seriously and departmental disciplinary proceedings should be initiated against such delinquents.

(ii) *Identification of Public Authorities*

As defined in Section 2(h) of the Right to Information Act, public authorities include institutions and non-governmental organisations, which are controlled or substantially financed by the Government. But some institutions like aided schools and colleges, managements of religious institutions and places of worship, libraries etc., which are either controlled or substantially financed by the Government are under the impression that provisions of the Right to Information Act are not applicable to them. Hence, in order to avoid any ambiguity in the matter, it is recommended that each administrative department of the Government examines the issue, publish the list of public authorities under them and also instruct such public authorities to comply with the provisions of the Right to Information Act, 2005.

(iii) *Appointment of Public Information Officers*

Government had issued instructions and guidelines to all public authorities on the designation of State Assistant Public Information Officers, State Public Information Officers and the Appellate Authorities in all administrative units/offices. These instructions have been complied with to a great extent by most of the public authorities. But there are still some public authorities who have not yet designated the State Assistant Public Information Officers, State Public Information Officers and the Appellate Authorities. This is especially so in the case of Non-Governmental Organizations, financed by the Government like the aided colleges and schools. Hence it is recommended that all administrative departments of the Government are directed to review the progress of implementation of the Right to Information Act starting from the designation of SAPIO/SPIO/AAs at different levels in the administrative units/offices. It is

also suggested that in the case of major offices, there should be more than one State Public Information Officer as contemplated under Section 5(1) of the Act to receive and dispose of applications under Section 6(1) of the Right to Information Act. Hence, it is recommended that in major offices, adequate number of State Public Information Officers may be designated.

It is also found necessary that the State Assistant Public Information Officers/State Public Information Officers/Appellate Authorities should display appropriate name boards for easy identification by the citizens. It is recommended that all public authorities may be given instructions to exhibit name boards of SAPIOs, SPIOs and AAs at conspicuous places in the office premises.

The State Information Commission had requested the Government to designate separate State Public Information Officers and Appellate Authorities in the Offices/Administrative wings of all Ministers including Chief Minister in order to avoid the situation of rejection of non-acceptance of application/Appeals under the Right to Information Act, 2005 for want of designated State Public Information Officers and Appellate Authorities.

Government have in G.O. (Rt.) No. 1795/2011/GAD dated 10-3-2011 designated State Public Information Officers and Appellate Authorities in the office of Ministers and Chief Minister.

(iv) *Inadequacy of Office Contingency Fund and Office Equipments*

State Public Information Officers of some Government Offices have reported that they were finding it difficult to meet the expenditure for providing information for want of sufficient fund allocation. The Commission has been harping on this issue in the previous reports also. There are many offices which are still not provided with photocopiers to take photocopies of documents. Hence, it is suggested that all Government Offices may be provided with adequate funds to meet the cost of providing information under the Right to Information Act. It is also recommended that action may be taken to provide computers and photocopiers in all Government Offices in a phased and time bound manner.

(v) *Dissemination of Information*

It is the statutory duty of the State Public Information Officers to provide the information or reject the requests for information, as provided in Section 7(1). If the applicant is not satisfied with the reply given by the Public Information Officer, the applicant has the right to appeal before the Appellate Authority of the public authority under section 19(1) of the Right to Information Act, 2005. It is necessary that the reasons for not providing the information, the period within which the appeal may be preferred and the particulars of appellate authority be clearly indicated while responding to the requests for information. It is recommended that all officers of public authorities may be given adequate training on the dissemination of information as envisaged under the Act.

(vi) *Disposal of First Appeals*

Section 19(1) of the Act provides for taking up a matter on first appeal before the first Appellate Authority in the public authority, when the applicant is not satisfied with the information provided by the SPIO of the public authority. The first appellate authority is to dispose of the appeal within a maximum period of 45 days. In many cases, it is seen that the first appellate authority either deals with the appeal late or does not dispose it at all. This inevitably results in the delayed receipt of information and/or the applicant is compelled to take up the matter on 2<sup>nd</sup> appeal before the State Information Commission, with its concomitant delay, additional expenditure and avoidable agony. Even in the case of timely disposal of first appeals, it is often noticed that the First Appellate Authorities do not meticulously and judiciously examine the complaints raised in the first appeal or hear the parties before taking the decision. They either agree with the decision of the SPIO blatantly or issue hasty and ambiguous directions to the SPIO. This, in practice, makes the first appeals a farce. Here again, the Commission would stress on providing training to the concerned officials to improve their perception of and performance under the Act.

(vii) *Harassment of Applicants*

There have been instances where the applicants faced harassment and oral threats from officers/employees of certain public authorities. This might have probably happened due to the ignorance of the officers/employees of the public authorities about the provisions of the Right to Information Act. Not only the appellate authorities, Public Information Officers and Assistant Public Information Officers but other employees of the public authorities also may be given adequate training on the provisions of the Right to Information Act.

(viii) *Maintenance and Retrieval of Records*

In many cases of disposal of requests asking for copies of documents, it was noted that the Public Information Officers fail to retrieve the documents requested because of absence of a proper system of record keeping. Section 4(1)(a) of the Right to Information Act requires that the public authorities shall maintain all its records duly catalogued and indexed in a manner and form which facilitates the right to information. Record keeping is an area neglected in most of the offices of Government and Public Sector Undertakings. Government may make a special drive in this direction so that the records available in the offices of the public authorities are properly catalogued, indexed and stored in a manner that facilitate easy retrieval of information.

(ix) *Inclusion of Right to Information Act in the School Syllabi*

Information is indispensable for the functioning of true democracy. People have to be kept informed of the functioning of the public authorities in the Government at large. Right to Information Act, 2005 is a cardinal legislation having its base in the democratic principles, especially the freedom of speech and expression guaranteed under the Constitution to each and every citizen of India. Hence, it is recommended that a chapter on the Right to Information Act, 2005 is incorporated in the school syllabi at high school level.

(x) *Intelligence and Security Organisations*

Section 24 of the Act provides that the provision of the Right to Information Act, 2005 shall not apply to the Intelligence and Security Organisations specified in the second schedule being organizations established by the Central Government or any information furnished by such organizations to that Government. In tune with this provision 8 organisations have been included in the notification issued under S.R.O. No. 127/06 dated 7-2-2006. The Commission would like to draw the attention of the Govt. to the fact that a large number of organizations and wings have been exempted from the purview of the RTI Act without proper application of mind. Only organizations dealing with intelligence and security matters and that too subjects relating to the above aspects should be excluded from the purview of the Act. Blanket exemption granted to such organizations u/s 24 of the Act defeats the objective and true spirit of the Act. The Commission urges the Government to review the exemption granted under the above provision.

(xi) *Digitisation of Records*

Registers and records to be maintained on a permanent basis are to be digitized for their proper maintenance and easy retrieval. Complaints of loss of records are plenty and urgent steps are warranted for their digitization on an urgent basis. The General Administration Department may issue clear guidelines with adequate provision for funds so that the efforts in this regard are undertaken with all seriousness it deserves.

(xii) *Pendency of Complaint Petitions and Second Appeals*

The huge pendency of complaint petitions and second appeals in the State Information Commission has been the result of lack of timely appointment of Information Commissioners. The Commission has been working with one or two Information Commissioners for considerable periods resulting in piling up of large pendency. The Government is requested to appoint the Chief Information Commissioner and the 5 Information Commissioners well in time so that the complaint petition and second appeals are attended to in time.

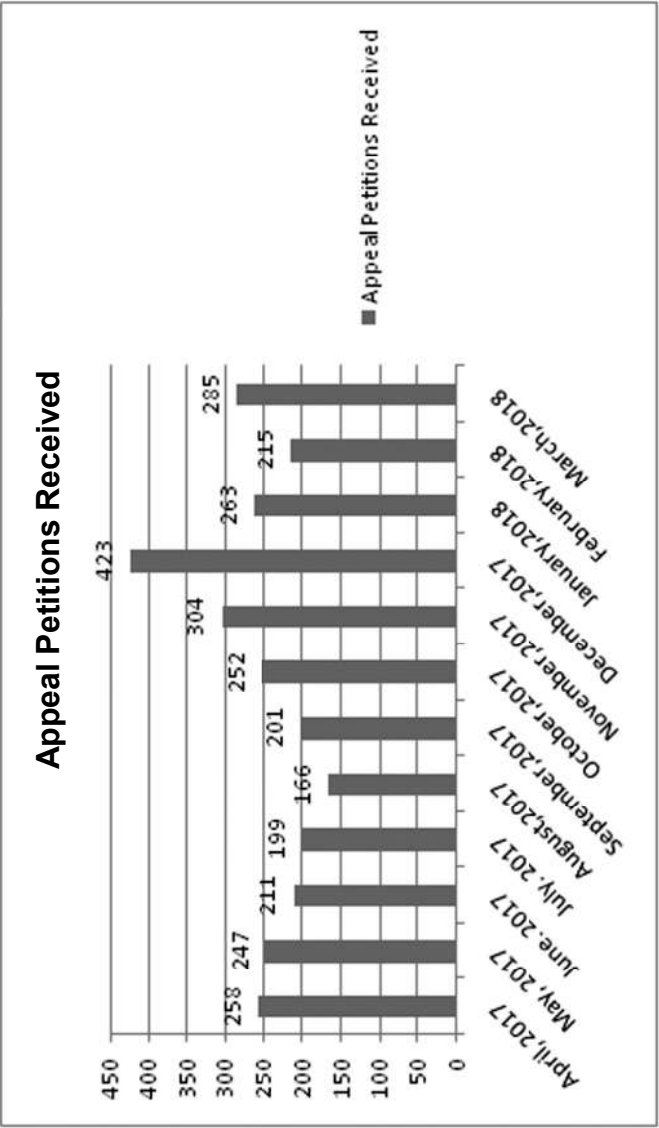

7. State and Regional Forensic Science Laboratories
8. State and District Fingerprint Bureau
9. Home (SS.A) and Home (SS.B) Departments in the Govt. Secretariat (sensitive/confidential/secret papers received from the Special Branch CID, Crime Branch CID, District Special Branches of all Districts/Cities, District and State Crime Records Bureaus, Police Telecommunication Unit, Confidential Branch in the Police Headquarters, Kerala and Confidential Sections in all Police Offices in Kerala, State and Regional Forensic Science Laboratories, State and District Fingerprint Bureau).
10. State Vigilance and Anti-Corruption Bureau "T"—Branch. However, the information pertaining to allegations of corruption and human rights violations are not exempted from disclosure in the case of these exempted organisations. In the case of allegations of violation of human rights, the information shall be provided only after the approval of the State Information Commission and the information shall be provided within 45 days from the receipt of request.

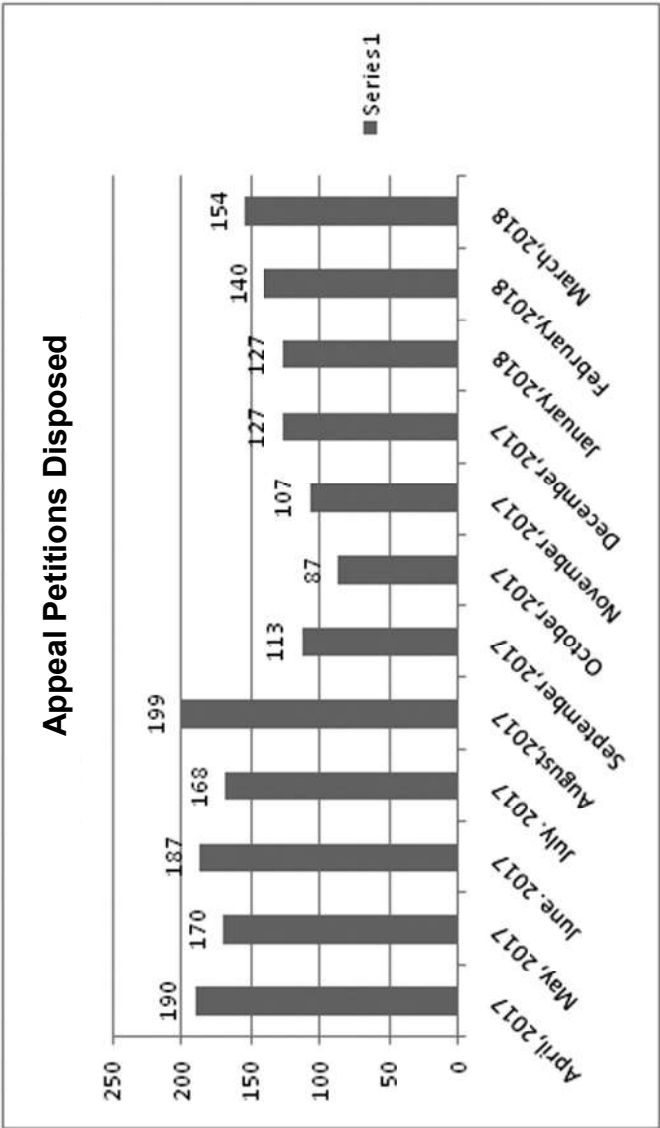

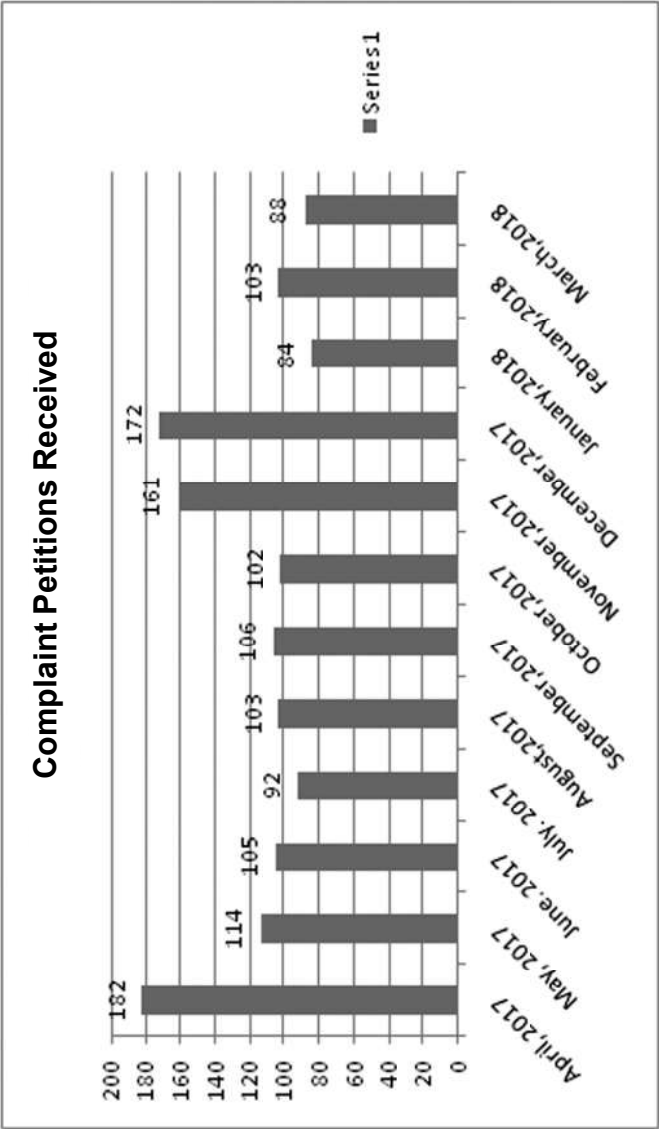
Graph Showing the Status of Appeal Petitions Received



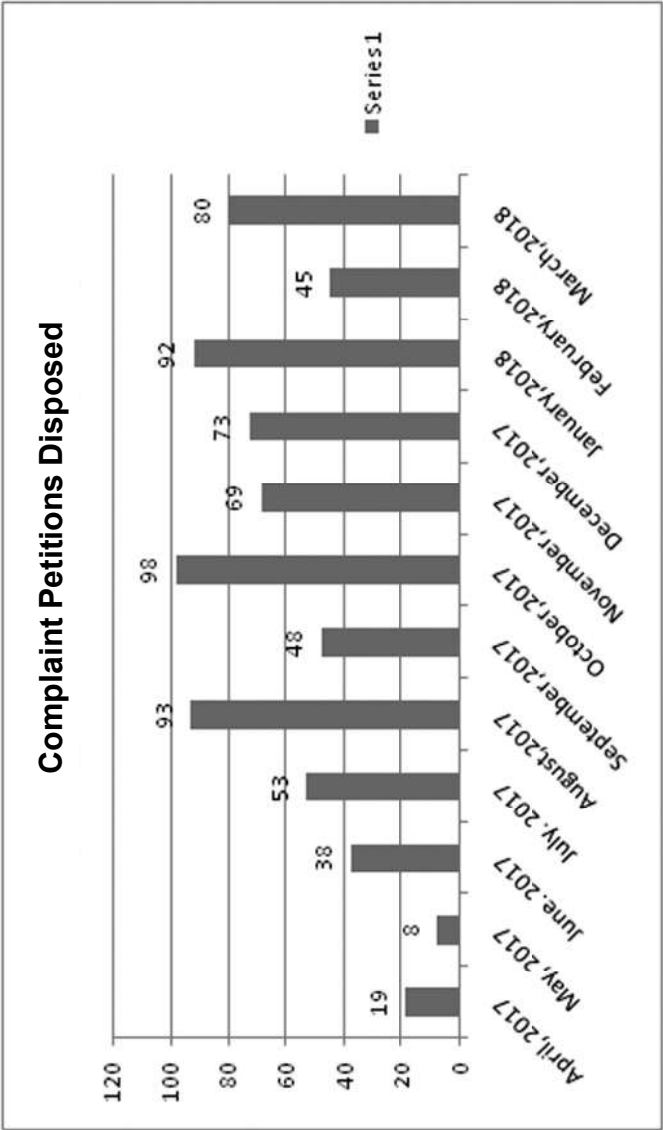
Graph Showing the Status of Appeal Petitions Disposed
