O., Thrissur, as the State Information Commissioners of the Kerala State Information Commission, constituted as per Notification No. 80649/Cdn.5/2005/GAD dated 19th December, 2005, published as S. R. O. No. 1091/2005 in the Kerala Gazette Extraordinary No. 2731 dated 19th December, 2005.

### Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

As per sub-section 2 of section 15 of the Right to Information Act, 2005, the State Information Commission shall consist of a State Chief Information Commissioner and such number of State Information Commissioners not exceeding ten, as may be deemed necessary. The Government of Kerala have decided that the State Information Commission shall consist of four State Information Commissioners. The State Information Commissioners shall be appointed by the Governor, on the recommendation of a committee constituted for the purpose. The committee has now recommended to appoint Shri P. Faziluddin, News Editor, Kerala Kaumudi, Thiruvananthapuram and Shri P. N. Vijayakumar (Retired District and Sessions Judge), "Indeevaram", M. R. Vasu Road, Ayyanthole, Thrissur, as the State Information Commissioners in addition to the existing one State Information Commissioner. Accordingly the Governor of Kerala has ordered to appoint the above personnel as the State Information Commissioners of the Kerala State Information Commission.

This notification is intended to achieve the above object.
