Explanatory Note

(This does not form part of the notification but is intended to indicate its general purport.)

The Kerala State Information Commission was constituted with a State Chief Information Commissioner and four State Information Commissioners as provided under sub-section (2) of section 15 of the Right to Information Act, 2005 as per notification No. 80649/Cdn. 5/05/GAD dated 19th December, 2005, published as S. R. O. No. 1091/2005 in the Kerala Gazette Extraordinary No. 2731 dated 19th December, 2005. Two State Information Commissioners Shri P. Faziluddin, News Editor, Kerala Kaumudi, Thiruvananthapuram and Shri P. N. Vajayakumar, Retired District and Sessions Judge, Indeevaram, MR Vasu Road, Ayyanthole, P.O. Thrissur appointed as per notification No. 80649/Cdn.5/2005/GAD dated 25th April, 2006 and published as S. R. O. No. 320/2006 in the Kerala Gazette Extraordinary No. 785 dated 25th April, 2006 had relinquished their charge on attaining the age of 65. Government as per sub-section (3) of the said section have now recommended to appoint Shri M. N. Gunavardhanan, Flat No. 2B, Anitha Park, Nalumukku Jn., Pettah, Thiruvananthapuram-695 024 and Shri Soni Thengamom, "SARASAM", 14, Kadappakkada Nagar, Kadappakkada P.
