### ORDER

Appeal Petitioner Sri. Jain Natarajan represented before the Commission that no information was provided on his application by the 1<sup>st</sup>

Respondent. Hence an appeal was filed before the 2<sup>nd</sup> Respondent. However, there was no response by the 2<sup>nd</sup> Respondent either.

2. In his application Submitted before the 1<sup>st</sup> Respondent, the Appellant sought the following information:

- i) The Name and official designation of the Officer taking care of petition No.3061/18/B4 dated 27.01.2018.
- ii) Whether the above petition was accepted for enquiry. If not, when the enquiry was going to start and so on numbering to 5 items.

3. The Appellant filed his first appeal before the 2<sup>nd</sup> Respondent stating that the information sought by him was not provided by the 1<sup>st</sup> Respondent.

4. In the report furnished before the Commission by the 1<sup>st</sup> Respondent, it was stated that information as required by the Appellant was furnished to him on 22.02.2018. However, the above reply came back from the postal department stating that the addressee was “not known”. However, on receipt of the hearing notice from the Commission, the above reply was again sent to the Appellant on 25.01.2020 incorporating a copy of the reply already furnished to him.


