ORDER

Complaint Petitioner Smt. Remadevi alias Devi, represented before the Commission that the information sought by her has not been furnished till date by the Respondent.

2. In her application submitted before the Respondent, the Complaint Petitioner sought the following information:

i. Copy of BTR in respect of property in resurvey No.102/6, Block 40, TP No.42, resurvey No.56/2, 44/1/, 44/2 and 44/3.

ii. Copy of Adangal register in respect of the property covered as per resurvey No.102/6, block 40, TP no.42, resurvey No.56/2, 44/1,44/2 and 44/3.

In the report submitted to the Commission by the Respondent, it was stated that reply to the application was furnished to the Compliant Petitioner on 2.3.2015 and that the above reply was sent to her by registered letter. Thereafter, the Complaint Petitioner submitted the same application on 11.3.2015. No reply was furnished thereon as reply on the same matter was furnished on 2.3.2015. Thereafter, the Complaint Petitioner was sent a copy of the reply on 22.5.2015 by registered post.

3. In view of the facts indicated in the report, the Commission finds no merit in the Complaint Petition and hence the same is dismissed on the 14th day of January, 2020.
