Appeal Petitioner Sri.Nonda U.Jayarama, in his second appeal dated 01.06.2016, represented before the Commission that the first Respondent had denied information stating that the file is not available in the office. He filed an appeal before the second Respondent, the reply to which stated that they are not in a position to find out the required documents he had sought. Hence he requested the Commission to take necessary steps to enable him to obtain the information sought by him.

- 2. The above appeal was taken on file as AP.No.1465(2)/16/SIC and the Commission conducted a detailed hearing into the matter on 25.05.2019 in which the first Respondent was present. The Appellant was absent.
- 3. In his application submitted before the first Respondent, the Appellant sought the following information:

A clear copy of Letter No.D.Dis-2322/99 dated 12.03.1999 with enclosures if any as quoted in para 5 of the letter No.D.Dis-6222/2015/G, dated 30.03.2016.

- 4. Reply to the above application was that the file No. D.Dis-2322/99 from which copy of order dated 12.03.1999 which was requested by the Appellant was not available in the office and the matter had already been mentioned in the proceedings issued in D.Dis-6222/2015/G, dated 30.03.2016 of Sub Collector Kasargod at Kanhangad. But a letter issued to Tahsildar, Kasargod regarding the rejection of his first appeal against the cancellation of assignment is available in the concerned LA file which is now kept in Taluk Office, Manjeswar. Then the Appellant filed an appeal before the second Respondent.
- 5. On scrutinizing the appeal petition and connected documents, the Commission finds that the Respondents had furnished replies to the Appellant within the prescribed time limit and that the information furnished was based on the facts available with the Respondents. Hence

the Commission concludes that no further action is warranted in this appeal.

6. The Commission disposes of this appeal petition accordingly on the 13^{th} day of March, 2020.
