ORDER

Appeal Petitioner Sri.Jeejo S., in his second appeal dated 27.10.2017 (which was received in the office of the Commission on 31.10.2017), represented that he had filed an application under the RTI Act before the Respondent office. The information sought by

him was not sent by the First Respondent till date. Hence the first appeal was filed before the second Respondent. He further stated that the second Respondent also did not furnish any reply. The Appellant requested the Commission to take necessary action against the officers concerned and to furnish the information sought by him.

2. The above appeal was taken on file as AP.No.2214(2)/17/SIC and a detailed report was sought from the Respondent on 03.07.2018.

3. In his application submitted before the first Respondent on 27.07.2017, the Appellant sought the following information:

The copy of full set of agreement along with agreement schedule signed by the Chief Engineer(Works), TDB with the Contractor late Sri.L.Sajeenan, Eravipuram, Kollam for the work of "Construction of Pampa –Chalakkayam Road Phase-I".

- i) The item wise quantity of work executed against the agreement quantity of the work of "Construction of Pampa – Chalakkayam Road Phase-I".
- ii) The total amount already paid to the Contractor against the executed quantity (Item wise) and the balance quantity executed by the Contractor and the amount due to the contractor for the work of "Construction of Pampa – Chalakkayam Road Phase-I" if any and so on numbering to 17 items:

Reply to the above application was furnished on 14.08.2017 and a copy of the reply was sent to the Appellant along with the copies he required in his application. As per the direction of the Commission the

copy of the same along with all the documents were sent to the Appellant once again.

4. On scrutinizing the appeal petition and connected documents, the Commission finds that the Respondents had furnished replies to the Appellant within the prescribed time limit and that the information furnished was based on facts available with the Respondents. As such, the Commission does not find any merit in the second appeal and hence the same is dismissed on the 5th day of January, 2020.
