No. 1091/2005 in the Kerala Gazette Extraordinary No. 2731 dated 19th December, 2005.

Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Kerala State Information Commission was constituted with a State Chief Information Commissioner and four State Information Commissioners as provided under sub-section (2) of section 15 of the Right to Information Act, 2005 as per notification No. 80649/Cdn.5/05/GAD dated 19th December, 2005, published as S.R.O. No. 1091/2005 in the Kerala Gazette Extraordinary No. 2731 dated 19th December, 2005. The State Information Commissioner Dr. K. Rajagopal, Divyam, VRA 118, Vazhottukonam, Vattiyookavu P. O., Thiruvananthapuram-13 appointed as per notification issued under G. O. (Ms.) 230/08/GAD dated 15th July, 2008 and published as S.R.O. No. 760/2008 in the Kerala Gazette Extraordinary No. 1517 dated 15th July, 2008 had relinquished his charge after completing his term of office. As per G. O. (Ms.) No. 85/2012/GAD dated 25th April, 2012 the Government created one more post of State Information Commissioner in the Kerala State Information Commission. The Committee constituted as per sub-section (3) of the said section have recommended the Governor to appoint Shri C. S. Sasikumar, Panchavadi 'O' Street, Jawahar Nagar, Kowdiar P. O., Thiruvananthapuram and Dr. Kurias Kumblakuzhy, Kumblakuzhy House, Ettumanoor, Kottayam-686 631 as State Information Commissioners in the existing vacancies. Accordingly, the Governor of Kerala have ordered to appoint the above persons as State Information Commissioners of the Kerala State Information Commission.

The notification is intended to achieve the above object.
