Explanatory Note

(This does not form part of the notification, but is intended to indicate its general purport.)

The Kerala State Information Commission was constituted with a State Chief Information Commissioner and four State Information Commissioners as provided under sub-section (2) of section 15 of the Right to Information Act, 2005 as per notification No. 80649/Cdn.5/05/GAD dated 19th December, 2005, published as S. R. O. No. 1091/2005 in the Kerala Gazette Extraordinary No. 2731 dated 19th December, 2005.

The State Chief Information Commissioner Shri Palat Mohandas, 'Araman', T. C. 4/2117, Vikramapuram Hills, Kuravankonam, Pattom Palace, P. O., Thiruvananthapuram and the State Information Commissioner Shri V. V. Girija, Pulimottil House, V. V. Road, Vanchiyoor, P. O., Thiruvananthapuram appointed as per notification No. 80649/Cdn.5/2005/GAD dated 19th December, 2005 and published as S. R. O. No. 1092/2005 in the Kerala Gazette Extraordinary No. 2731 dated 19th December, 2005 had relinquished their charge after completing their term of office. The Committee as per sub-section (3) of the said section have now recommended to appoint Dr. Siby Mathews, T. C. 14/229, Silver Hills, Anayara, P. O., Thiruvananthapuram-695 029 and Shri K. Natarajan, "Geethas" VRA 175, Mannamoola, Peroorkkada, Thiruvananthapuram as the State Chief Information Commissioner and State Information Commissioner respectively, in the existing vacancies. Accordingly the Governor of Kerala have ordered to appoint the above persons as the State Chief Information Commissioner and State Information Commissioner of the Kerala State Information Commission.
